# Instructor Certification Requirements and Expectations



#### **Purpose of Instructor Training**

As mentioned previously, the Instructor Training is for individuals who are interested in getting up in front of groups and teaching Green Dot to adults in the Bismarck-Mandan community. The ideal candidate will have experience with public speaking, community mobilizing and/or violence prevention work. If you have none of those things but are passionate about preventing violence in our community, and think you could learn, please join us!

### What will be expected of you?

- Devote time and energy to learning, personalizing and adapting content
- Facilitate at least one presentation within the first 90 days
- Facilitate at least one Green Dot presentation per month (on average)
- Teach the program with fidelity

- Utilize evaluation tools provided
- Attend monthly Instructor Gatherings
- Collaborate with other Green Dot team members
- Support action events
- Practice what you preach

### What do you get out of the training?

- An introduction to the Green Dot model and a new language of prevention
- A comprehensive understanding of the research base of Green Dot and its application
- Effective strategies for address long standing points of resistance
- A personalized script used for implementation of the Green Dot Bismarck-Mandan.
- A 15-90 minute persuasive speech used to introduce Green Dot and build support
- Detailed curriculum used for implementation of the 6-7 hour Green Dot Bystander Training
- A practical, evidence based model to guide your community mobilization efforts
